ORDER

In the reference 1st read above, Government have issued orders introducing "Residential Entrepreneurship Development Programme and Skill Development Programme Scheme for SC/ST Entrepreneurs" for the benefit of existing SC/ST Entrepreneurs in the State of Andhra Pradesh.

- 2. In the reference 2^{nd} read above, the Commissioner of Industries has furnished the Operational Guidelines for implementation of "Residential Entrepreneurship Development Programme and Skill Development Programme Scheme for SC/ST Entrepreneurs" issued vide 1^{st} read above and requested the Government for approval of the Guidelines.
- 3. After careful examination of the Guidelines proposed by the Commissioner of Industries, GoAP, Vijayawada, Government hereby issue the following Operational Guidelines for implementation of "Residential Entrepreneurship Development Programme and Skill Development Programme Scheme for SC/ST Entrepreneurs" issued vide reference 1st read above:

Operational Guidelines for Residential Entrepreneurship Development Programme and Skill Development Programme Scheme for SC/ST Entrepreneurs:

1.0. Introduction

The Government of Andhra Pradesh has launched the **Entrepreneurship Development programme and Skill Development Programme Scheme** for the benefit of SC/ST Entrepreneurs through the G.O.Ms.No.185 of Industries and Commerce (P&I) department dated 20.12.2016. As part of this scheme, training programmes will be organised on free of cost.

2.0. OBJECTIVE

The objective of the scheme is to identify the suitable SC/ST prospective entrepreneurs who are intending to become entrepreneurs. The Government imparts necessary training in Entrepreneurship Development and Skill Development on free of cost, in reputed institutions like EDI, IGIAT, NI-MSME, CIPET, CFTRI, CLRI, CITD, etc.,

3.0. ELIGIBILITY

- 3.1. The following eligibility criteria should be met by SC/ST Entrepreneurs to avail benefit under this scheme
 - Domicile of Andhra Pradesh in age group of 18-50 years
 - o Caste Certificate issued by Government of Andhra Pradesh
 - Minimum qualification: 10Th Pass

4.0. APPLICATION PROCESS

4.1. Application Form and Process

- 4.1.1. The eligible SC/ST Entrepreneurs shall apply through an online at www.apindustries.gov.in, separately for Entrepreneurship Development and Skill Development. If the entrepreneurs applied for both Entrepreneurship Development and Skill Development the application will be considered for EDP first.
- 4.1.2. The Application Form provided in Annexure I /II as applicable
- 4.1.3. The following documents shall accompany the application form:
 - i. Caste Certificate Issued by competent authority of Government of Andhra Pradesh.
 - ii. 10th class or Higher pass certificate.
 - iii. SSC certificate or any other document in proof of age.

5.0. SELECTION PROCESS OF ELIGIBLE CANDIDATES:

5.1. Scrutiny and Verification Mechanism

- 5.1.1. GM, DIC shall ascertain that the candidate's eligibility under these guidelines and submitted required documentation.
- 5.1.2. If any document is found incomplete or short fall, the GM, DIC shall take necessary steps to receive the required documents within 15 days.
- 5.1.3. The following Scrutiny and Verification Committee (SVC) shall verify the applications/documents and interview the candidates for both Entrepreneurship Development Program and Skill Development Program separately and recommend the merit list for sanction by the DIPC.

5.1.4. The applications verified by the SVC shall be placed before the DIPC for sanction, at least once in a month.

6.0. EMPANELMENT OF ORGANIZATIONS / INSTITUTIONS OF EXCELLENCE

6.1. State Level Committee: The State Level Committee comprising the following members shall finalize the empanelment of State Government / Central Government / Private Partner Training Institutes from time to time:

6.2. The residential Entrepreneurship Development programme for 2 (two) weeks: Empanelment of the State Government / Central Government / Private organisations/Institutions will be done, by calling for proposals. All such proposals shall be placed in the State Level Committee for finalisation of the empanelment from time to time.

6.3. Residential Skill Development programme for 2 to 3 months:

Empanelment of the State Government / The Central Government / Private organisations/Institutions will be done by calling for proposals with details of different Skill Development programmes offered by them. All such proposals shall be placed in the State Level Committee for finalisation of the empanelment from time to time.

7.0. IMPLEMENTATION

• Basing on the batch size the applicants will be distributed among the institutions by the SLC from time to time.

8.0. DISBURSEMENT OF FUNDS

- 8.1. 50% of the total course fee shall be paid in advance to the training institutions. The balance amount will be paid on successful completion of the training program, based on the number of candidates trained and certified, duly placing before the SLC for final payment.
- 8.2. The expenses shall be met from the following heads of account within the budget.
