In the G.O.7th read above, Government have issued certain fiscal incentives/benefits to SC& ST Entrepreneurs, among others under Industrial Development Policy, 2015-20.

2. Government, after careful examination of the references read above, hereby approves the introduction of "Reimbursement of course fee for Contractor Development Programme Scheme" for benefit of SC/ST Entrepreneurs in the State of Andhra Pradesh.

Introduction

Government of Andhra Pradesh shall reimburse course fee subject to maximum of Rs.1,00,000 per head excluding boarding and lodging expenses incurred by SC/ST entrepreneurs for participation in Contractor Development Programme detailed below in reputed national level institutions:

These development programmes shall be held at reputed institutions of excellence such as NAC, L&T, GMR, Government of Andhra Pradesh and Government of India etc. organisations. Training shall be imparted across a wide spectrum of civil works execution services related vocations.

Eligibility

- 1. Domicile of Andhra Pradesh in the age group 18-50 years.
- 2. SC/ST caste certificate issued by Government of Andhra Pradesh.
- 3. Minimum qualification/class Diploma/Degree in engineering.

Identification

Eligible candidates can apply to the local District Industries Centre office with supporting documents.
